

Building Control – Fees January 2011



The standard fees in the following tables have been set on the basis that:

- The building work does not consist of, or include, innovative or high risk construction techniques and/or the duration of the building work from commencement to completion does not exceed 12 months.
- The design and building work is undertaken by a person or company that is competent to carry out the relevant design and building work referred to in the standard fee tables.

If the above criteria are not met, the work may incur a supplementary fee.

VAT at the rate of 20% is included except within the Regularisation fees.

Where electrical installations are **not** to be certified by an installer registered with one of the Governments Competent Persons Schemes an additional fee of £197.04 incl of VAT will be required for each unit. This is to enable checks and tests on the work to be made by our nominated contractor to establish that the work meets with the requirements of Approved Document P.
